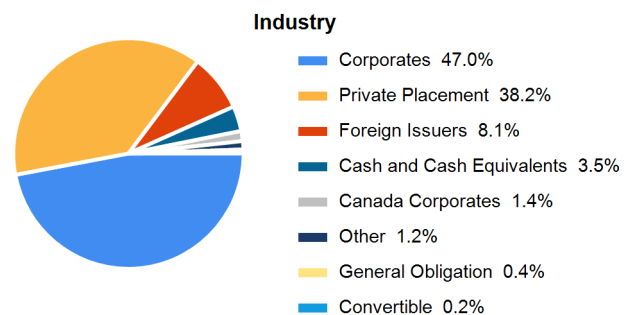
What does the fund invest in?

The fund primarily invests in high-yield fixed income securities (i.e., non-investment grade rated debt instruments) issued by corporations primarily located in the U.S. The charts below give you a snapshot of the fund's investments on May 31, 2011. The fund's investments will change.

How has the fund performed?

This section tells you how the class has performed over the past 0 year(s). Returns are after expenses have been deducted. These expenses reduce the class's returns.

Average return

A person who invested \$1,000 in the class on 3/5/2010 now has \$1,209 as of 5/31/2011. This works out to an annual compound return of 16.56%.

Are there any guarantees?

Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

Who is this fund for?

Investors who:

- are looking for income and the potential for capital gains primarily through investments in non-investment grade bonds/securities of U.S. issuers;
- are comfortable with low to moderate investment risk (i.e. they are willing to accept some fluctuations in the market value of their investment);
- are willing to hold their investment for the medium to long term; and/or own or plan to own other types of investments to diversify their holdings.

Before you invest in any fund, you should consider how it would work with your other investments and your tolerance for risk.

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Class O (H) units of the fund. The fund has other classes of units. The fees and expenses are different for each class. Ask about other classes that may be suitable for you.

1. Sales charges

No sales charges are payable for purchases made directly through the manager or authorized brokers and dealers.

2. Fund Expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of December 31, 2010, the fund's expenses were 0.16% of its value. This equals \$1.60 for every \$1,000 invested.

Management expense ratio (MER)

This is the total of the fund's management fee and operating expenses.

SEI Investments Canada Company waived some of the fund's expenses.

If it had not done so, the MER would have been higher.

Trailing commission

SEI Investments Canada Company does not pay trailing commissions to investment firms for this class of units.

3. Other Fees

You may have to pay other fees when you sell or switch units of the fund.

Fee	What you pay
Short-term trading fee	A short-term trading penalty of up to 2% on the redemption price of Units redeemed within 90 days of the date upon which the Units were purchased. The penalty is paid to the Fund and not to SEI Investments Canada Company.
Switch fee	No switch fees are payable for switches made directly through the Manager or authorized brokers and dealers.
Change fee	No change fees are payable for changes made directly through the Manager or authorized brokers and dealers.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- Withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus, or
- Cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
